

2020 Player's Club Agreement "Silver"

The Player's Club Pass entitles the Passholder to the following benefits:

- Unlimited use of practice area
- 2 Complimentary rounds of golf per month
- 7 day booking window for tee times reservations.
- 20% off merchandise (Soft Goods)
- 10% off merchandize (Hard Goods)
- All benefits can be used at Teravista, Avery Ranch, and Falconhead Golf Clubs.

The Player's Club Pass shall be issued in the name of the Passholder. Passholder acknowledges that children under 16 years of age must be signed into the Club by a parent or guardian, and children under 11 years of age must be accompanied by a parent or guardian while at the Club.

The term of this Month-to-Month Player's Club Agreement (this "Agreement") is monthly and shall commence on the date this Agreement is executed and payment of the first monthly Plan Fee is received by the Club. Either party may terminate this Agreement by giving thirty (30) days advance written notice of termination. Passholder is responsible for all fees incurred during the thirty-day (30-day) notice period, regardless of which party elects to terminate. The Club may modify the monthly Plan Fee and benefits upon at least thirty (30) days advance written notice to Passholder.

Passholder agrees to maintain a current credit card account in Passholder's name on file with the Club at all times. In the event that Passholder's account is more than thirty (30) days past due, Club has the right to bill such past due amounts to Passholder's credit card. Passholder agrees to immediately notify the Club of any changes in credit card information and understands those changes must be done through the Pro Shop staff. Do NOT reply to billing notifications! Passholder further agrees that the Club is not responsible for any fees incurred as a result of the Club billing Passholder's credit card (e.g., for overdrawn accounts, exceeding credit card limits, etc.). While you are active in the program, the rounds of golf that are included in this plan will carry over for three months and may not be used passed the 90th day. If you cancel or fail to pay for this plan the carried over rounds are terminated. Rounds are good only for the registered active Passholder and cannot be shared.

Passholder understands that the monthly Plan Fee will not be waived under any circumstances, regardless of whether the Passholder exercised the benefits of the Player's Club Pass in a given month.

The "Silver" Monthly Plan Fee is \$99.99 per month and will be billed on the 3rd of each month to the credit card number listed below. To make account changes or cancel, please communicate with our Pro Shop staff. Do NOT reply to billing notifications.
